#### 17/35 Welcome

Cllr Lower, as Acting Chair, opened the meeting and welcomed Pamela Martin and Mrs Callingham.

Mrs Callingham spoke about the Brook Cottage planning application in that she has lived next door at Pondside for 50 years. Brook Cottage does not sit in the centre of the plot and therefore the proposed extension will cause overshadowing and a diminution of light. The dominant wall abuts Pondside with only a small gap inbetween. A playroom has been demolished and she believes this is the obvious place for the proposed extension which will be a 'granny flat'.

Cllr Gay estimated the distance between the boundary and Brook Cottage to be 3-4 metres. Mrs Callingham stated that both an upstairs bedroom and sitting room will be affected by a loss of light.

This is a reapplication of the 2014 planning application which was granted permission. To date there have been 4 objections.

Pamela Martin publicly thanked Cllr Gay for his help in tidying up the rear storeroom of the pavilion.
