19/51 Chairman's welcome

Cllr Crossley welcomed all to the meeting and congratulated all Councillors on being re-elected unopposed and thanked them all for their hard work.

Richard Bourne was invited to speak. He mentioned the parking issues along Jumps Road and that one neighbour who was inactive is now back on side. Over 50 cars were parked there the first May bank holiday weekend. Need to make contact with the new chairman of Frensham PC.

19/58 Committee and portfolio responsibilities and reports

19/58.1 Community and Environment (SR)

Cllr Ryland commented on how much she enjoyed the annual assembly, hearing what the other village societies are up to.

How are C roads assessed? Many in need of repair. Jumps Road and Old Barn Lane have been assessed by a machine utilised by SCC and are to be surface dressed.

Cllr Ryland mentioned a climate change emergency motion to be put to Waverley BC, Haslemere and Godalming town councils in July. If passed elements of this will filter down to the parishes. Could Churt adopt a similar protocol?

New councillor Natasha Fletcher at Frensham will join the informal discussion regarding a possible lighting policy.

19/58.1.1 Village Centre portfolio (RC)

Kai in village shop needs to seek planning for condenser unit on roof and needs to reduce height of surrounding trellis.

Fallen tree in Barford Stream reported to SCC. Clerk to contact rights of way team as bridleway B1 is SCC's responsibility.

On Hants side it is only a footpath not a bridleway. Tree fallen from Hants side onto Surrey side of stream.

19/58.1.2 Crime and Disorder (RC)

Very few reported break ins. Few car number plates stolen. Reported crime in Surrey down by 6%. 8th lowest county in UK for break ins. Marginal rise in knife crime.

19/58.2 Roads and Transport

19/58.2.1 Jumps Road parking and sculpture park (KL)

A working group has been formed comprising Cllrs Law, Martin and Pamela Andrews from Frensham. They have now met with Eddie Powell from the Sculpture Park. Mentioned concerns re the parking situation, the fact farm machinery cannot go down Jumps Road, issue with school coaches dropping off, people parking and blocking sight lines out of driveways etc. Asked what solution might be? There is no other land that could be used for parking.

Sculpture Park has 11 designated car parking spaces. Is there a shared agreement with the Bel and Dragon? Parking in B and D car park on a first come first served basis with 8 spaces for staff. B and D do not police the car park as they hope to get business from people visiting the Sculpture Park.

Sculpture Park now has 30,000 visitors pa with a spike at weekends. They will carry out a survey to find where visitors come from.

Eddie Powell suggested the verges are tidied up.

Richard Bourne to join the working group.

Cllr Crossley thanked Cllrs Law and Martin for all their efforts.
