RGT 26/43.1 Payments for authorisation – May 2026

May's accounts **Proposed** by Cllr S Shorthose, **seconded** by Cllr S Wright and **agreed** by all.

It was **agreed** by all that the Clerk would transfer £10,000 in June into the CAF account, **proposed** by Cllr S Shorthose and **seconded** by Cllr T Wright.

It was noted that the RGT does not have a credit card account to take donations at the fete for BAB. Cllr M Shorthose, who is also a Trustee of the Tilford Bach Festival (TBF) offered a credit card machine used by TBF. The donations received would be transferred directly back to RGT at cost and would not be retained by TBF. Cllr M Shorthose will provide the credit card records to enable the donations to be tracked and giftaid collected. It was recognised that this pragmatic solution was acceptable since there was insufficient time to set up a RGT Square account. However, Cllr M Shorthose and Cllr Barrow will set up a suitable account with Square for future collections.

Clerk to seek quotes to repair potholes along Redhearn Green in front of Church.

Cllr Raeside will be in charge of choosing 3 trees to plant on the Rec. in the Autumn in order to discharge Condition 4 of the planning permission for the pavilion.

Cllr Raeside will also look into installing higher chestnut posts bordering the entrance and exit points to the parking on the Green.
